## Kerrville Coed Softball (Lease Fields for Spring Season)

- Fundraising card sales- pizza party for first team to sell all their cards.


## 30 ${ }^{\text {th }}$ Anniversary T-Shirt/Cap Sales

- James requests Board's input on if we should offer/sell T-Shirt \& Caps for $30^{\text {th }}$ anniversary.
- James suggests taking orders and payments in advance of actual placing orders.
- Board discusses having order forms go through the Concession stand and offering online orders via our website (for payments by Paypal).
- Questions on shirt colors, cost, and time frame for delivery.
- In upcoming week, James will find cost, Josh to review design, Catie will do paper order form. Additional discussion to be held via email or ad hoc meeting in the coming week.

## Sponsorships
