## Registration Planning

- James \& Ray say they will be present at all registrations
- Bonnie \& Delma will need to check work schedules for the weekday ones, but should be at weekend registration.
- James to send email to board members to determine who all can assist with registrations.
- Confirmed we will have receipts for any cash payments; do not feel it is necessary for other payments (check, credit card) as those are traceable.
- Flyer will go out in schools' newsletters prior to registrations; postcards will also be sent at the end of December to all existing league families.
- Pre-filled forms will be available for players from prior season.


## Fundraising Manager(s)

Two suggested fundraisers currently in research stage:

- Krispy Kreme: sell dozen original glazed donuts. Cost is $\$ 4.00 /$ dozen with a minimum purchase of 100 dozen. Cost for 100 dozen: $\$ 400$. If we sell for $\$ 8.00 /$ dozen, profit is $\$ 400.00$.
- Bonnie \& Delma to determine where/when to sell. Perhaps Gibson's/Walmart/Moore's Furnishing/TJ Moore.
- Suggest posting sale in Kerrville Online Garage sale for exposure.
- Sara offers to pick up donuts on date to sell and transport to Kerrville.
- Bonnie \& Delma to bring proposed dates/locations to next board meeting for approval (including final determined amount to purchase)
- Popcorn bags: this would be the player fundraiser. Cost for full-size bag is 90 cents a bag, suggest purchasing 10 cases (100 bags per case). Cost is $\$ 900$; if sold at $\$ 3.00$ a bag, profit is $\$ 2,100.00$.
- Supplies are from Deanan's Popcorn in Converse, Tx.
- Profit based on final sale price
- Multiple flavors can be purchased


## Treasurer's Report

- There is still approximately $\$ 500.00$ in payments to clear.
- Motion to approve made by Ray; seconded by Bonnie; motion carried unanimously.


## Sponsorships Manager

- James reports a couple of signs were sold last month.
- Renewals are coming up in January/February.
- Target sales is $\$ 4,000$ this year.


## General Discussion

- Flyers announcing registration dates will be posted at several local businesses (Josh has done in past).
- Ad announcing registration also runs in West Kerr Current - free of charge.
- Ray suggests notice includes that we are accepting 13 year-olds; James says it is not necessary to highlight that as the postcards/notices will note the registration fees for various age groups (up to 14 years old)
