- Bonnie reports there are still 100 bags of popcorn to sell with plans to sell from concessions or bonnie will have a table at an upcoming game.
- Still missing popcorn money from 18 players.
- Some people have paid the \$20 buyout to not sell, but never turned in their popcorn.
- Bonnie will send James a list of the teams with money/popcorn outstanding and James will email the team managers to collect the money.

Sponsorships Manager

- James thinks some advertisers still owe with some renewals due this month totaling approx. \$1,000-\$1,500.
- James notes Remax will not advertise again.

Facilities & Maintenance Manager

- Josh reports sprinklers are going every morning and notes that Ray and managers/coaches need to start putting the tarp on the field to protect it.
- Lights need to be fixed
- Johnny has been doing a great job mowing.
