Welcome,

Ingram Little League will complete its 2018-19 season at the end of September, 2019.

This season, even with all the challenges we faced, I believe we ended on a positive side and everyone involved had a fun season. For our 2017-18 season we had 123 registrants and 109 participating players. While the number of registrants was down 3 this season, the participating players were up by 7.

We were able to acquire a grant from the Hal & Charlie Peterson Foundation that allowed us to make much needed improvements to the complex, and improvements that were simply cosmetic but enhanced the overall appeal of our complex.

To cap the season off, we were selected by our District Administrator as the host site for seven (7) Little League All Star tournaments - up from two (2) the previous season - Minors Baseball & Majors Softball. In addition, due to a rainout in Boerne, we also hosted the last two games of the Intermediate Baseball All Star tournament. This makes the eighth consecutive season Ingram Little League has been selected to host Little League All Star tournaments - District and Sectional. The Sectional baseball tournaments were hosted at the Ingram High School baseball field. All other tournaments were hosted at our Ingram Little League complex.

This is the second consecutive season we have provided our practice fields as parking area for the Texas Arts and Crafts Fair hosted by the Hill Country Arts Foundation. And, the third consecutive year we have done the same for the Celtics Games (We also extend the use of our bleacher for this event.).

Speaking for the Board in its entirety, we thank everyone for their participation this past season - players, coaches and volunteers - and look forward to the 2019-20 season being a fun season.

- The League did not acquire real property. Donations of a Cushman ATV & John Deere mower were accepted.

### Grants

- A grant was received from The Hal & Charlie Peterson Foundation in the amount of \$56,315. Those funds were specified for, and used for:
  - Concrete Pads for all Bleacher areas
  - Concrete floors for all dugouts
  - Rockwork around all backstops
  - Renovation of restrooms to semi-comply with ADA standards
  - Purchase of new pitching machines
