    - Application

    - Appointed by President
    - Approved by the Board
  - The following are necessary and sufficient conditions for being a "Regular Member". These are set by our Constitution and State Law
    - Application
    - Background Check
    - Training ("or any equivalent update")
    - Appointed by President
    - · Approved by the Board
- Member Roll must identify:
  - Member Name
  - Contact Info (phone & email address)
  - Appointed Position (e.g., Manager Craftsmen)
    - Needs to be specific
  - Eligibility (volunteer application, background check and child abuse awareness training)
  - BOD Approval Date (individual member)
  - Note 1: Do not include home addresses or any additional info.
