Presidents Report:

1. Registration is closed 167 - Tball remains open until Jan 22. *Will try to amend the post to clearly state Tball remains open thru 1/22.*
 - Assessments are Jan 23, 24, 25th.
 - Raffle tickets will be handed out at assessments and then additionally during open gyms in March (1/\$500, 2/\$250 3/\$100, 4/\$50). \$1500 in prizes. There are extra raffle tickets for any person who wishes to sell them for \$5 each. Winners will be pulled on opening day.
2. We will host open gyms on January 5, 14, and 16th (not team specific).
3. Will also host open gyms in March. These will be team specific/times will be assigned. Sundays (1-5pm), Monday/Wednesday and Fridays 5:30-8:30. Tball will be given every other Sunday. Hopefully this helps coaches get some "practices" in with March weather being unpredictable.
4. Bingo is happening this Saturday, 1/10/26, at Porters Fire Company from 12-4. HELP is needed!
 - To date we have sold 150 tickets at \$35 (tickets increase to \$45 at the door), making our profit roughly \$1000.
 - Prize examples: \$7k worth of Yeti, two first class tickets, TV, lotto basket
 - Venmo only at Bingo concessions due to gambling laws
 - Many concession items were donated (water, chips). Still in need of ground beef, pork, candy, mints.
 - \$3 refill cups for the concession stand. (*firehall charges \$1 once per soda

 - b. 2 trucks for ZV (the split for the fields will be 1/2, 1/2, 1)

 - **Will have separate funds, fundraisers etc. from NELL.**
 - **Will have their own fields.**
 - **Will have their own scholarships to offer (*starting in 2027).**
 - **ZV meetings will now require attendance from NELL and Fast Pitch board.**
