2020 Player Evaluations

SATURDAY, JANUARY 25, 2020 - (ALL PLAYERS AGE 8-12) @ St. Vincent's High School -849 Keokuk St, Petaluma,

We will begin evaluations **promptly at 9:15 am**. Please see below to view the specific times for your child's evaluation time. Please use **LITTLE LEAGUE** and the **FIRST LETTER OF YOUR LAST NAME** to find the correct evaluation time. Players should **arrive about 15 minutes early** to warm up and register.

Players should bring a glove, bat, and helmet for tryouts. Due to the artificial turf, players should wear plastic molded cleats or tennis shoes. After checking in and warming up, the players will run through a series of three drills. 1.) catch grounders and make short throws, 2.) catch flies and make longer throws, and 3.) swing a bat.

We will do our best to stay on schedule, but please be patient with the process. Evaluations tend to be a lot of waiting with a quick evaluation.

No food, sunflower seeds, coffee, or sports drinks are allowed on the fields.

Parent/Guardian Code of Conduct

When Registering for PNLL you marked a box that stated that you understand the code of conduct. This is a written copy of the code for your reference..

We, the Petaluma National Little League, have implemented the following and taunting; refusing to shake hands; or using profane language or Sport Parent Code of Conduct for the important message it holds about gestures.

the proper role of parents in supporting their child in sports. Parents should read, understand and sign this form prior to their children participating in our league.

Any parent guilty of improper conduct at any game or practice will be asked to leave the sports facility and be suspended from the following game. Repeat violations may cause a multiple game suspension, or the season forfeiture of the privilege of attending all games.

Preamble

The essential elements of character-building and ethics in sports are embodied in the concept of sportsmanship and six core principles:

- Trustworthiness,
- Respect,
- Responsibility,
- Fairness,
- Caring, and
- Good Citizenship.

The highest potential of sports is achieved when competition reflects these "six pillars of character."

I therefore agree:

- 1. I will not force my child to participate in sports.
- 2. I will remember that children participate to have fun and that the game is for youth, not adults.
- 3. I will inform the coach of any physical disability or ailment that may affect the safety of my child or the safety of others.
- 4. I will learn the rules of the game and the policies of the league.
- 5. I (and my guests) will be a positive role model for my child and encourage sportsmanship by showing respect and courtesy, and by demonstrating positive support for all players, coaches, officials and spectators at every game, practice or other sporting event.
- 6. I (and my guests) will not engage in any kind of unsportsmanlike conduct with any official, coach, player, or parent such as booing

- 7. I will not encourage any behaviors or practices that would endanger the health and well being of the athletes.
- 8. I will teach my child to play by the rules and to resolve conflicts without resorting to hostility or violence.
- 9. I will demand that my child treat other players, coaches, officials and spectators with respect regardless of race, creed, color, sex or ability.
- 10. I will teach my child that doing one's best is more important than winning, so that my child will never feel defeated by the outcome of a game or his/her performance.
- 11. I will praise my child for competing fairly and trying hard, and make my child feel like a winner every time.
- 12. I will never ridicule or yell at my child or other participants for making a mistake or losing a competition.
- 13. I will emphasize skill development and practices and how they benefit my child over winning. I will also de-emphasize games and competition in the lower age groups.
- 14. I will promote the emotional and physical well being of the athletes ahead of any personal desire I may have for my child to win.
- 15. I will respect the officials and their authority during games and will never question, discuss, or confront coaches at the game field, and will take time to speak with coaches at an agreed upon time and place.
- 16. I will demand a sports environment for my child that is free from drugs, tobacco, and alcohol and I will refrain from their use at all sports events.
- 17. I will refrain from coaching my child or other players during games and practices, unless I am one of the official coaches of the team.
