

## **NJBSL 2026 Meat Raffle Fundraiser**

### **Official Terms & Conditions:**

1. **General.** By participating in the “NJBSL 2026 Meat Raffle Fundraiser” (the “Raffle”), entrants agree to be bound by these “Official Terms and Conditions” and by the decisions of the Northwest Junior Baseball Softball League, Inc. (“NJBSL”), which shall be binding and final as to all matters related to the Raffle. The Raffle is subject to all applicable federal, state, and local laws and is void where prohibited.
2. **The Raffle Period.** The Raffle will run from April 27, 2026 12:00 am to May 29, 2026 5:00 pm EST, (the “Raffle Period”).
3. **The Prizes.** Four Raffle tickets will be drawn as winning tickets. Rather than awarding actual cuts of meat, this year’s prizes will be **gift cards to Duma Meats, Inc.** for the approximate value of each prized cut of meat. The 1<sup>st</sup> Place prize will be the approximate value of one Hind-Quarter of Beef plus extras (actual prize is a \$1,500.00 gift card); the 2<sup>nd</sup> Place prize will be the approximate value of one Hind-Quarter of (actual prize is a \$1,200.00 gift card); the 3<sup>rd</sup> Place prize will be the approximate value of one Half-Hog (actual prize is a \$300.00 gift card); and the 4<sup>th</sup> Place prize will be the approximate value of one Half-Hog (actual prize is a \$300.00 gift card).

These prize valuations were determined using pricing and average weights as listed by Duma Meats, Inc. at the beginning of the fundraiser. However, Duma Meats, Inc. may change the price of products at any time and the final weight of a purchase will affect the price due for any purchases made by winners. **NJBSL shall NOT be responsible for paying any extra money/gift cards to winners in the event that prices increase and/or the gift card does not cover the entire cost of an associated prize.** Winners may use gift cards to purchase the associated prize or any other items sold at Duma Meats, Inc. (subject to Duma Meats’ terms and conditions, locations in Mogadore, Ohio and Hartville, Ohio).

**Individuals may win only one prize** – in the case an individual’s name is drawn a second time, the second ticket will be removed and a new winner’s ticket shall be drawn. NJBSL Reserves the right to substitute like prizes if necessary, such as unavailability of a product.

4. **Charitable Proceeds.** All proceeds from the Raffle will benefit NJBSL, an Ohio 501(c)(3) non-profit corporation.
5. The Raffle is open to all persons age eighteen (18) and older unless such person is located in a territory that prohibits or otherwise limits participation in charitable raffle events at the time of purchase of a Raffle Ticket.

6. **Purchasing Raffle Tickets.** All Raffle Tickets may be purchased as follows: one (1) Raffle Ticket for \$10.00. All sales of raffle tickets will be made through the online fundraising platform, Zeffy.com, and purchasers agree to be bound by the terms of the Zeffy.com platform as may be found on their website (www.zeffy.com). Payments may be made through Zeffy via credit card, bank account, Google Pay, or other methods of payment as Zeffy may accept. There are no discounts or complimentary Raffle Tickets available. There is no limit to the number of Raffle Tickets an individual may purchase, although the total number of tickets available for sale will not exceed three thousand (3,000). Each entrant will receive a Raffle Ticket(s) from Zeffy.com, which is evidence of proof of purchase. Entries which are or appear to be tampered with are void. Each electronic raffle ticket purchased through Zeffy will correspond to a physical raffle ticket that is used to draw the winning tickets (i.e., the raffle ticket drawings will not be conducted electronically but will be held using physical raffle tickets drawn by hand). NJBSL shall be the sole judge of the validity and eligibility of all entries. All Raffle Ticket purchases shall be final, and no refunds or replacements will be issued by NJBSL. Raffle Tickets are only valid for the drawing held on May 31, 2026.
7. **Raffle Tickets are Not Tax Deductible.** Under IRS guidelines, amounts paid for chances to participate in raffles, lotteries, or similar programs are not gifts and, therefore, the price of the entry does not qualify as a deductible charitable contribution to NJBSL.
8. Each winner shall be responsible for any and all federal, state and local income or excise taxes, fees, assessments and like charges associated with a prize. At the time of this printing, federal law requires that a tax withholding on certain prize values must be collected from winners upon award and distribution. Federal and state withholding laws are subject to change without notice. The withholding laws in effect at the time each prize is claimed will be followed. Winners must submit a completed IRS Form W-9 to NJBSL before receiving their prize and prizes over Six Hundred Dollars (\$600) may receive a W-2G form from NJBSL if required by the IRS. Taxes will be withheld in accordance with IRS and State of Ohio guidelines.
9. **Selection of Winner.** One (1) Raffle Ticket will be drawn by NJBSL to determine the winner of each of the four prizes. The drawing will be held on May 30, 2026 (time to be determined) at the NJBSL Complex located at 8845 Erie Ave N, Canal Fulton, Ohio 44614 and streamed through a Facebook Live broadcast on the NJBSL Facebook page (subject to any network blackouts that may occur outside of the control of NJBSL). Winners need not be present at the time of the drawing. In the event of inclement weather preventing the drawing from being held at the NJBSL Complex, an alternate location may be selected at the discretion of NJBSL. The numbers of the winning Raffle Tickets will be announced on NJBSL's website and/or Facebook page and through other media at the discretion of NJBSL.

10. **Prize Claim.** Within thirty (30) days of the applicable drawing, each prize claimant must notify NJBSL and provide confirmation of their identity corresponding to the winning Raffle Ticket to claim the prize associated with that Raffle Ticket. Prize claimants must provide NJBSL with all information required to claim a prize (including tax identification information) and may be required to submit additional form(s) to NJBSL. Upon confirmation of winning tickets, NJBSL will provide the winner with their gift card to Duma Meats, Inc. (857 Randolph Rd., Mogadore, OH 44260). Winners will be able to use their gift cards for any purchases at Duma Meats, Inc. as allowed by the merchant. NJBSL shall not coordinate the actual purchase of any items from Duma Meats, Inc. on behalf of the winners, and the winners are not obligated to purchase the corresponding cut of meat associated with their prize (e.g., a winner of a hind-quarter of beef may choose to use the gift card on item(s) different than a hind-quarter of beef). Should NJBSL be required to use a merchant other than Duma Meats, Inc., winners will be notified of said change. In the event a claimant: (a) does not notify NJBSL within thirty (30) days of the drawing; (b) is ruled ineligible for any reason; (c) refuses the prize; or (d) does not return any required information/forms, the prize will be forfeited and will be retained by NJBSL for charitable use. NJBSL may attempt to contact potential prize winners but has no obligation to contact potential winners. No cash payments will be made to the winners.
11. **Odds.** The odds of winning the Raffle depend on the number of Raffle Tickets purchased for the drawing. The maximum number of raffle tickets being sold for this Raffle are three thousand (3,000).
12. **Transfer of Raffle Tickets or Prize.** Persons who purchase Raffle Tickets may opt to give away their Raffle Tickets to other eligible persons, but in doing so the purchaser waives any claim he/she might otherwise have to the prize. Purchasers of Raffle Tickets may not re-sell their Raffle Tickets to other parties, and may not knowingly give Raffle Tickets away to others for the purpose of allowing those other parties to re-sell such Raffle Tickets. All Raffle Tickets which have been resold in violation of these Official Terms and Conditions shall be void. All individuals who re-sell, purchase, or receive Raffle Tickets in violation of these Official Terms and Conditions shall be ineligible to participate in the Raffle or to win a prize. A winner may transfer his/her prize to a third party provided that the following conditions are met: (a) the transferee would have otherwise been eligible to enter the Raffle (age eighteen (18) or older); (b) the transferee shall be responsible for all taxes and costs described in these Official Terms and Conditions; and (c) the transferee shall be bound by all terms and conditions of these Official Terms and Conditions that are applicable to the winner.

13. The Raffle will be conducted and supervised by NJBSL whose decisions are final. NJBSL reserves the right, in its sole discretion, to cancel or suspend the Raffle should unauthorized human intervention or other causes corrupt the administration, security, fairness, integrity or proper operation of the Raffle.
14. **Release of Liability.** By entering into the Raffle, all entrants agree to: (a) be bound by these Official Terms and Conditions; and (b) release NJBSL together with its members, employees, officers, directors, sponsors, representatives, volunteers and agents, from any and all liability with respect to any injury, damage or loss that may occur, directly or indirectly, in whole or in part, from the participation in the Raffle, or from any travel or activity related to the receipt or use of any prize.
15. **Publicity Release.** Each winner, by accepting a prize, grants NJBSL and its designees and affiliates, full permission, except where legally prohibited, to use such winner's name, address (city and state only), photograph, voice and/or other likeness, and prize information for advertising, trade and promotional purposes without further compensation and without notice, review or approval, in all media now known or hereafter discovered, worldwide and in perpetuity. Each winner shall execute all documents that NJBSL may require to be signed in connection with this release.
16. **Winning Numbers.** A list of winning numbers for each prize can be obtained by sending a request to NJBSL at P.O. Box 332, Canal Fulton, Ohio 44614 with a stamped, self-addressed return envelope postmarked between June 1, 2026 and July 1, 2026. Any such request for a list of winning numbers will not extend the 30-day window for winners to claim prizes.
17. **Governing Law.** The Raffle and these Official Terms and Conditions shall be subject to and governed by the laws of the State of Ohio. If a court of competent jurisdiction finds that any provision of these Official Rules, or their application to a particular persons or circumstances, is invalid or unenforceable to any extent, then the remainder of these Official Terms and Conditions shall remain enforceable to the fullest extent permitted by law. The sole jurisdiction and venue for any cause of action arising out of the Raffle or these Official Terms and Conditions shall be the courts located in Stark County, Ohio.
