Old Business:

 - o T-ball will be Northwest vs. Tuslaw weekly, likely Tuesdays and Thursdays.
 - o SCBA contact updated.
 - o Umpire money needed, \$75/game.
- Softball starts this week. Max of 8 home games.
- Martin motioned to give all remaining candy in concession stand to football and all remaining water to umps and kids.
 - o Barnart second.
 - Vote: all in favor.
- Martin to text Justin Smith for update regarding parking lot start date.
 - o 6 truck loads of grinding delivered for parking lot.
 - o Permanent Rotary club sponsorship sign needs to be purchased.
- Travel ball teams as of now are:
 - o 12U-12 attended tryouts, taking 11.
 - o 11U-16 attended tryouts, taking 11.
 - 9U- 12 attended tryouts, 3 players left for other programs. 1 player was unable to come to tryouts but has requested to join team. That puts team at 9 players. As of now, not enough players to form team. Looking at options to pursue other Northwest kids vs non Northwest kids.
 - o Placing an October 1 deadline to find more players.
- Distribution of funds from remaining fundraising funds to return to league at end of season.
 - We will not be lowering registration fees with remaining balance.

 - o Rotary club sign
 - o Handicap signage will be dependent upon total number of spots.
 - o Spools of yellow rope, U-channel, stainless steel hardware, and no parking signs will also need purchased for completion of project.
 - o Martin motioned to buy all items listed above.
 - Seconded by Barnhart.
 - Vote: all in favor
