### ***Fundraising***

### ***Registration & Teams***

Registration opens November 1, 2025 at \$185.00. Registration closes February 28, 2026; late fee \$250.00. Opening Day: April 19, 2026. Team Draft: March 14, 2026. Anthony Frascogna will assist Mike Bazoge with the draft. Two ghost T-Ball teams will be created for late registrants. If not filled, those teams will hold practice. T-Ball limited to 8 players per team.

### ***Little League Tournament***

Tournament dates: May 15–17, 2026 at Sipp Avenue Complex. District leagues will be invited; each team must bring a raffle basket as entry fee. Umpires and winner t-shirts will be funded by the league. Raffle proceeds and snack stand revenue will offset costs.
