

# McCormick Ranch Little League Covid-19 Player/Parent Certification

I further certify that I take full responsibility for making sure that my player and my family are aware of and will follow all of the McCormick Ranch Little League COVID-19 protocols, waivers, and safety measures. I will provide my player with hand sanitizer (60% alcohol or higher) or soap and water and a face covering, for all team events to be used as necessary or required by law.

I further certify that before every McCormick Ranch Little League practice and game, I will verify that my player does not have a temperature over 100.5 degrees and can answer 'NO' to all the COVID-19 symptom screening questions found on the [mrlbaseball.org](https://www.cdc.gov/coronavirus/2019-ncov/symptoms-testing/symptoms.html) website and/or the CDC website. (<https://www.cdc.gov/coronavirus/2019-ncov/symptoms-testing/symptoms.html>) If my player has a temperature over 100.5 degrees or answers 'YES' to any of the COVID-19 symptom screening questions, I will not permit my player to attend any AZ Playball team events until cleared by our health care provider. In addition, I will be required to provide the coach and MRLLE with written clearance from the health care provider.

I further certify that I will take full responsibility to make sure that all of the protocols and safety measures are followed by my player, and that I will not allow my player to participate in any team activities until his/her necessary COVID-19 waiver and protocol forms have been signed and returned to the coach.

I further certify that I will notify my coach immediately if my player has contracted the COVID-19 virus and/or if my player has been in contact with any person that has contracted the COVID-19 virus.

I further certify that I understand that if any player on my team contracts the COVID-19 virus or comes into contact with anyone who has contracted the COVID-19 virus, that my team will not be allowed to have any McCormick Ranch Little League practices or games for a period of 14 calendar days from the date that the player contracted the virus or came into contact with another person who had contracted the virus.

I further certify that I understand that any games or practices that are missed due to the COVID-19 situation will be made up if feasible, but the possibility exists that they will not.

I further certify that I understand that once practices begin, if the season is not completed due to Covid-19 or governmental requirement, I understand that any team refunds/credits will be pro-rated.
