### By signing this form you agree to the following:

I live within the boundaries of Oceanside National Little League and have played in at least 60% of the season that I am eligible for. If I am selected to an All Star Team, I understand that I must be available for practices beginning as early as June 1st (generally 5 to 6 days per week for at least 2 hours) and for all games as early as June 24<sup>th</sup> through July 31<sup>st</sup> for 9/10, 10/11 year-old and Junior teams, and through August 31<sup>st</sup> for Major Division teams. While my All Star Team may not advance through District to State or Regional tournaments, **I agree to make every effort to not schedule vacation, summer camps or other activities that will interfere with my ability to attend practices and games during the tournament period. If I cannot commit to the entire tournament period (June 1<sup>st</sup> through July 31<sup>st</sup> or August 31<sup>st</sup> for Major Division team), those dates are listed below.** I understand that the All Star Manager has the discretion to remove the player from the team if absences occur other than those listed.

I, the parent/guardian of the above named All Star Team candidate, hereby gives approval for my child to participate in all tournament activities and agree to make my child available for all activities throughout the District 70 tournament and all subsequent tournaments for which the All Star Team qualifies. **I also agree to make available my child's original birth certificate for age verification purposes and any required documents needed to verify residency within the ONLL boundaries. If I am unable to produce the required documents, I understand that my child will not be included on the team roster.** I also understand that ONLL only funds team tournament fees, pins, hats and required baseball equipment, but does not reimburse for other related expenses, including personalized uniform, jackets, hotel and travel.

If my child becomes unavailable for any reason, other than short-term illness, I understand that his/her position on the team roster may be forfeited.

I understand that minimum play for the All-Star tournaments is 1 defensive inning and 1 at-bat.

**ONLL will collect \$100.00 to cover the cost of a customized All Star jersey and hat that the player will be able to keep at the end of the All Star season. Also the tournament charter and tournament baseballs will come out of this fee.**
