PROSPECT LITTLE LEAGUE 2021 SEASON WAIVER AND RELEASE FORM

ASSUMPTION OF RISK / WAIVER OF LIABILITY / INDEMNIFICATION AGREEMENT In consideration of being allowed to participate in **Prospect Little League** youth baseball programs and related events and activities, the undersigned acknowledges, appreciates, and agrees that:

- 1. Participation includes possible exposure to and illness from infectious diseases including but not limited to MRSA, influenza, and COVID-19. While particular rules and personal discipline may reduce this risk, the risk of serious illness and death does exist. I understand that my participation might involve certain risks, including, but not limited to: physical or psychological injury, pain, suffering, injury, illness, temporary or permanent disability, and economic or emotional loss.
- 2. I KNOWINGLY AND FREELY ASSUME ALL SUCH RISKS, BOTH KNOWN AND UNKNOWN, EVEN IF ARISING FROM THE NEGLIGENCE OF THE RELEASEES OR OTHERS, AND ASSUME FULL RESPONSIBILITY FOR MY PARTICIPATION.
- 3. I willingly agree to comply with both the stated and customary terms and conditions for participation. If, however, I observe any unusual or significant hazard during my presence or participation, I will remove myself from participation and bring such to the attention of the nearest league official immediately. I agree to follow the rules provided to me and to follow directions given to me.
- 4. I hereby certify that I am physically fit, have the skill level required, and have not been advised otherwise.
- 5. I agree that the purpose of this agreement is that it shall be an enforceable RELEASE OF LIABILITY AND INDEMNITY as broad and inclusive as is permitted by Connecticut law. I agree that if any portion or provision of this agreement is found to be invalid or unenforceable, then the remainder will continue in full force and effect. I also agree that any invalid provision will be modified or partially enforced to the maximum extent permitted by law to carry out the purpose of the agreement.
- 6. I, FOR MYSELF AND ON BEHALF OF MY HEIRS, ASSIGNS, PERSONAL REPRESENTATIVES AND NEXT OF KIN, HEREBY RELEASE AND HOLD HARMLESS **PROSPECT LITTLE LEAGUE**, **THE CONNECTICUT WATER COMPANY AND SJW GROUP, AND EACH THEIR OFFICERS**, **OFFICIALS, AGENTS, SHAREHOLDERS, AND/OR EMPLOYEES, OTHER PARTICIPANTS**, **SPONSORING AGENCIES, SPONSORS AND ADVERTISERS ("RELEASEES")**, WITH RESPECT TO ANY AND ALL ILLNESS, DISABILITY, DEATH, OR LOSS OR DAMAGE TO PERSON OR PROPERTY, WHETHER ARISING FROM THE NEGLIGENCE OF RELEASEES OR OTHERWISE, TO THE FULLEST EXTENT PERMITTED BY LAW.
