Open the Meeting, Jairus Motions to approve the November 3rd meeting minutes, Lizzie and Kyle second, all in favor.

Sharing of the Agenda -

League Taxes - The CPA has received the retro years information and has successfully sent the revised tax returns to the IRS. League board members agreed to continue using a CPA for tax purposes moving forward.

Board Vacancy - Jessica Robinson has resigned from her position as Treasurer. The Board acknowledged her commitment and service to so many areas of the community and her willingness to support the league in other capacities this coming year. The Board will look for a new Treasurer to fill the role. Kendra Driver has volunteered to continue to coordinate Treasurer duties until the position is filled.

Budgets - Board members submitted their budget requests which were largely in line with previous years. Current league balances and projected revenue for registration, sponsorships and fundraising were reviewed. Each department's budget request was approved and the overall league budget was established.

2026 Registration - The Board projected similar registration numbers to last year. From that, and agreeing to use \$10,000 in other revenue (sponsorship/fundraising) to subsidize registration costs, the Board set the following Registration Fees for each division:

\$100.00- TBALL

\$135.00- COACH PITCH

\$175.00- AA/AAA/MAJORS Softball and Baseball

\$200.00- JUNIORS/INTERMEDIATES Baseball

The Board approved a \$10.00 late registration fee if members register on or after February 1st, 2026.

The Board approved continuing the Sibling Discount for members registering more than one player at the same rate as last year.

By-Law Suggestions - The Board reviewed the By-Laws as required in even years. The following recommendations/suggestions were made:

- Adding stronger language for all coaches/managers to keep draft results confidential.
- Discontinuing the practice of keeping 10 year olds in AAA and putting most 11 year olds in Majors and shifting to a stricter, “you get drafted where you get drafted” approach.
- Adding language to clarify parents/guardians can request specific division placement for their players. The Board will review each request and make a determination.
- Adding language to clarifying sibling clauses for the draft.
- Adding language about all-star coach selection rankings to conclude after an equal number of inner-league games have been played by each team.
