

# West Pasco Girls Fastpitch Softball Association (WPGFSA)

## COVID-19 Guidelines

---

### Overview

WPGFSA has prepared the following guidelines to prevent the spread of COVID-19 during practice and games.

---

### Practices & Games

1. All efforts to maintain social distancing, 6 feet apart, during practices and games will be made.
  2. No more than 3-4 players/coaches will be allowed in a single dugout at any given time. No dugout use will be preferred.
  3. All warmups, stretching, team exercise, etc. will maintain the proper spacing.
  4. All personal gear shall be hung on the fence, 6 feet apart.
  5. Lines for all drills will maintain proper spacing.
  6. If social distancing cannot be maintained, PPE will be used.
  7. Players will be responsible for bringing and using their own PPE and antibacterial products (to contain at least 60% alcohol).
  8. Players will be responsible for bringing their own drinks and snacks, not to be shared by other players.
  9. Parents will maintain social distancing practices at all practices and games.
  10. Any Player or Parent who is feeling ill, will not practice or play in games. Stay Home.
  11. Coaches will enforce social distancing and correct players when not being followed.
  12. All physical contact by Coaches & players will be avoided, i.e. shaking hands, fist bumps, hugs, etc..
  13. Players will arrive early to practices and games but stagger their entrance as to avoid forming groups.
  14. The use of carpools or van pools to games or practices will be limited.
  15. Body temperature will be taken prior to practice or game admission.
  16. A log will be maintained with dates and attendance for practices and games.

### Hygiene & Equipment Care

1. Players will wash or wipe their hands with antibacterial soap or wipes before and after practices and games.
  2. All team equipment (Softballs, nets, etc...) will be sanitized post use by the coaches.
