



## Volunteer Youth Coaching Contract

I understand that my responsibilities as a Volunteer Youth Coach are of great importance and that my actions have the potential to significantly influence the young athletes I coach. Therefore, I promise to uphold the following rights of young athletes to the best of my ability.

All participants have the right to:

- Participate in sports
- Participate at an age appropriate level corresponding with each child’s maturity and ability
- Have qualified coaches
- Play as a child and not as an adult
- Participate in safe and healthy environments
- Have proper preparation for participation in sports
- Have an equal opportunity to strive for success
- Be treated with respect and dignity
- Have fun playing sports

I also promise to conduct myself in accordance with the Code of Ethics for Coaches as outlined here:

- I will treat each athlete, opposing coach, official, parent and program coordinator with respect and dignity.
- I will be a role model for the players by displaying good sportsmanship, appropriate conflict resolution, and effective communication.
- I will hold my players responsible for cleaning up after themselves.
- I will teach the players to not hang on the nets, not dig holes and to not kick the soccer balls against fencing.
- I will do my best to learn the fundamental skills, teaching, evaluation techniques, and strategies of my sport.
- I will become thoroughly familiar with the rules of my sport.

### Some of our common soccer rules that you are agreeing with:

No coach or spectator can sit behind or stand around the goals during games. Spectators are on one side of the field and coaches/teams are on the opposite side during games. A painted line will divide the two teams and each team will stay on their side and not cross into the other coach’s side. We will have designated game balls on the field when you arrive. If a coach notices a problem during a game, they will let the officials know during breaks and at no time approach the other teams’ players. No altering of uniforms is allowed without written permission from CCYS. No CCYS team may scrimmage or play a game against another league that’s not a CCYS team at any time due to insurance and safety protocols without written consent from CCYS (official season scheduled games are pre-approved). The officials are human also and we need to respect them. If the coach has an issue that’s not addressed, they need to speak with one of the field supervisors. The coach may have only one registered assistant on the sideline with them, no siblings or spectators (no coaching from the parents’ side). No Animals are allowed on any of the school’s fields. No smoking or drinking on school property. Please Note: No adults may be in contact or assist in any soccer activities (including practice) without first completing and passing a background check and volunteer application with Coos County Youth Sports. Coaches must arrive 20 minutes before practice and games start to get ready. During games, the soccer uniform will be the top layer of clothing. No private team events or functions are allowed without CCYS written permission. Anyone who does not comply will be asked to leave or be replaced immediately.
