

# DFAC Amateur Athletic Waiver and Release of Liability Form

In consideration of being allowed to participant in any way in the **Desert Foothills Athletic Club** (including, but limited to Desert Elite Basketball, Cave Creek Lacrosse, Phoenix Rising FC Desert Foothills, Rising Rec) athletic/sports program, and related events and activities, the undersigned:

1. Agrees that the participant prior to participating, he or she should inspect the facilities and equipment to be used, and if the participant believes anything is unsafe, he or she should immediately advise his or her coach or supervisor of such condition and refuse to participate.
2. **ACKNOWLEDGES AND FULLY UNDERSTANDS** that each participant will be engaging in **ACTIVITIES THAT INVOLVE RISK OF SERIOUS INJURY, INCLUDING PERMANENT DISABILITY AND DEATH**, and severe social and economic losses which might result not only from their own actions, inactions or negligence, but the action, inaction or negligence of others, the rules of play, or the condition of the premises or of any equipment used. Further, that there may be other risks not known to us or not reasonable or foreseeable at this time.
3. **ASSUMES ALL THE FOREGOING RISK AND ACCEPT PERSONAL RESPONSIBILITY FOR THE DAMAGES** following such injury, permanent disability or death.
4. **RELEASES, WAIVES, DISCHARGES AND COVENANTS NOT TO SUE** the **Desert Foothills Athletic Club**, its affiliated clubs, their respective administrators, directors, agents, coaches, and other employees of the organization, other participants, sponsoring agencies, sponsors, advertisers, and if applicable, owners and leasers of premises used to conduct the event, all of which are hereinafter referred to as "releases", from any and all liability to each of the undersigned, his or her heirs and next of kin for any and **ALL CLAIMS, DEMANDS, LOSSES OR DAMAGES ON ACCOUNT OF INJURY OR ILLNESS INCLUDING DEATH OR DAMAGE TO PROPERTY, CAUSED OR ALLEGED TO BE CAUSED IN WHOLE OR IN PART BY THE NEGLIGENCE OF THE RELEASEES OR OTHERWISE.**
