ASSUMPTION OF RISK AND RELEASE OF LIABILITY
(post COVID-19)

PLEASE READ BEFORE SIGNING:

In consideration of being allowed to participate in any way in the West End Little League, Beaumont, Texas baseball league/program, the undersigned acknowledges, appreciates, and agrees that:

1. The risk of injury to my child (Player) and myself, as a parent/spectator, from the activities involved in the baseball league/program is significant, including the potential for permanent paralysis or death, and while particular rules, regulations, equipment, and personal discipline may reduce the risk, the risk of serious injury does exist;
2. The risk of having direct or indirect contact with an individual who have been exposed to and/or contracted one or more communicable diseases, including but not limited to COVID-19 or other medical conditions, diseases, or maladies, and/or any mutation or variation thereof, does exist and, it is impossible to eliminate the risk that myself and/or my child (Player) could become infected through contact with or close proximity to an individual with a communicable disease;
3. I, both individually and as parent/guardian of the below-identified child (Player), KNOWINGLY AND FREELY ASSUME ALL SUCH RISKS AS DESCRIBED HEREIN, both known and unknown, even if arising from the negligence of the Releasees (defined hereinbelow) or others, and I ASSUME FULL RESPONSIBILITY FOR MY AND MY CHILD'S (PLAYER'S) PARTICIPATION;
4. I willingly agree that I and my child (Player) will comply with all of the league's rules and regulations, as well as all stated and customary terms and conditions for my and my child's participation in and with the baseball league/program. If, however, I observe any unusual, significant hazard during my presence or participation, I will remove myself and my child from participation and immediately bring such hazard to the attention of the nearest league official; and,
5. I, for myself and on behalf on my child (Player), as well as my and my child's (Player's) heirs, assigns, personal representatives and next of kin, HEREBY RELEASE AND HOLD HARMLESS West End Little League, Beaumont, Texas, as well as its officers, officials, agents and/or employees, other participants, sponsoring agencies, directors, sponsors, advertisers, and, if applicable, owners and lessors of the premises used to conduct the baseball league/program (collectively, the "Releasees"), WITH RESPECT TO ANY AND ALL INJURY, ILLNESS, DISABILITY, DEATH, OR LOSS OR DAMAGE TO PERSON OR PROPERTY, WHETHER ARISING FROM THE NEGLIGENCE OF THE RELEASEES OR OTHERWISE.

I HAVE READ THIS ASSUMPTION OF RISK AND RELEASE OF LIABILITY, FULLY UNDERSTAND ITS TERMS, UNDERSTAND THAT I, FOR MYSELF AND ON BEHALF OF MY CHILD (PLAYER), HAVE GIVEN UP SUBSTANTIAL RIGHTS BY SIGNING IT, AND SIGN IT FREELY AND VOLUNTARILY WITHOUT ANY INDUCEMENT.
