ASSUMPTION OF RISK / WAIVER OF LIABILITY / INDEMNIFICATION AGREEMENT REGARDING
COVID-19 AND OTHER COMMUNICABLE DISEASES

IN CONSIDERATION of my player's participation in **Smithtown Kickers/Slammers Club**, programming, training, and related events and activities ("Sanctioned Activities"), I acknowledge, understand, appreciate, and agree that:

1. Participation includes possible exposure to, and illness from, infectious diseases including but not limited to MRSA, influenza, and COVID-19. While particular rules and personal discipline may reduce this risk, the risk of serious illness and death does exist.
2. Participation is voluntary. If you believe the environment is unsafe, or you or your player are at heightened risk, you may refrain from participation until you believe it to be safe to do so.
3. If your player, or anyone in your household is experiencing symptoms of COVID-19, they will refrain from participation until safe to do so. If your player experiences any symptoms of COVID-19, you will report the symptoms immediately to the Club and your physician.
4. You will ensure that your player properly washes their hands, and any equipment they may personally use, prior to, and following, any participation.
5. You are responsible for the conduct of your player at all times, including your player's participation with **Smithtown Kickers/Slammers**. **Smithtown Kickers/Slammers**, is not the guarantor or enforcer of your player's conduct, and you agree you will have briefed and informed your player on **Smithtown Kickers/Slammers COVID-19 Protocols and Guidelines** and standards put forth by the Club, and government officials, regarding procedures that will be practiced on the field. You understand that you are solely responsible for the conduct and actions of your player. This includes strict adherence to coaching instructions. Players who do not follow instruction, will be asked to immediately leave the field, and may not be invited back until assurance can be provided that the player will adhere to all Club and government requirements.
6. During the initial phases of return to play, you understand and agree, that players may not carpool outside of their own family group, must supply their own ball, bring their own water supply, possess their own sanitizer, **wear masks in compliance with local guidelines**, and will socially distance from other players. You understand that you will also be responsible for washing your player's equipment and clothing prior to attending each training session. While the Club will also be in possession of sanitizers and may use these during training, you understand that masks and sanitizers may only help to lessen the possibility of transmission of the COVID-19 virus, and you understand that these do not prevent contraction of the virus.
7. You understand and agree, that during the initial phases of return to play, you will be prompt in dropping off and picking up your players from training, at locations designated by the Club.
8. You understand and agree, that you will not be permitted to congregate in parking lots, or in other areas, with other parents, and will socially distance and adhere to health requirements at all times related to your player's participation with **Smithtown Kickers/Slammers**.
9. You understand that insurance provided by **Smithtown Kickers/Slammers**, or other licensing bodies, does not cover for the risk or contraction of a communicable disease, including but not limited to, COVID-19.
10. You understand that failure to adhere to any of these provisions, or any other rule(s) set forth by the Club, City, County, State, Federal Government, or licensing bodies, will be immediate grounds upon which the Club may suspend your player.

11. You acknowledge the contagious nature of COVID-19 and voluntarily assume the risk that you/and or your player may be exposed to or infected by COVID-19 by attending SFC Sanctioned Activities and that such exposure or infection may result in personal injury, illness, permanent disability, and death. You understand that the risk of becoming exposed to or infected by COVID-19 at SFC Sanctioned Activities may result from the actions, omissions, or negligence of you/your player and others, including, but not limited to SFC employees, independent contractors, volunteers, and program participants and their families.
12. You agree to comply with the Slammers COVID-19 Protocols and Guidelines and if you/your player observes a violation of said protocols, you will remove yourself/your player from participation and bring such violation to the attention of the nearest official immediately.

I HAVE THE LEGAL AUTHORITY TO SIGN THIS AGREEMENT ON BEHALF OF MY PLAYER. I KNOWINGLY AND FREELY ASSUME ALL SUCH RISKS RELATED TO COVID-19 AND MY PLAYER'S PARTICIPATION WITH **Smithtown Kickers/Slammers** both known and unknown, EVEN IF ARISING FROM THE NEGLIGENCE OF **SFC** or others, and assume full responsibility for my player's actions and participation; and, I, for myself and on behalf of my player, player's otherparent, family members, heirs, assigns, personal representatives and next of kin, HEREBY RELEASE, COVENANT NOTTO SUE, DISCHARGE AND HOLD HARMLESS, **Smithtown Kickers/Slammers**, its directors and officers, officials, agents, independentcontractors, and/or employees, other participants, sponsoring agencies, sponsors, advertisers, and owners and lessors ofpremises used to conduct the event (Collectively "Releasees"), WITH RESPECT TO ANY AND ALL ILLNESS,DISABILITY, DEATH, or loss or damage to person or property, WHETHER ARISING FROM THE NEGLIGENCE OF RELEASEES OR OTHERWISE, to the fullest extent permitted by law. I, for myself and on behalf of my heirs, assigns, personal representatives and next of kin, hereby agree to defend and indemnify RELEASEES for all such claims, causes ofactions, allegations or matters arising out of, relating to, based upon or in any way connected to my participation inSanctioned Activities.

I HAVE READ THIS RELEASE OF LIABILITY AND ASSUMPTION OF RISK AGREEMENT, FULLY UNDERSTAND ITS TERMS, UNDERSTAND THAT I HAVE GIVEN UP SUBSTANTIAL RIGHTS BY SIGNING IT, AND SIGN IF FREELY AND VOLUNTARILY WITHOUT ANY INDUCEMENT.
