

## LOS ANGELES COUNTY POP WARNER WAIVER/RELEASE REQUEST FORM

Every LOS ANGELES COUNTY POP WARNER (LAC) Association has defined geographical boundaries. LACPW Associations shall register candidates who reside within the geographic boundaries of the Association. In the event a candidate for registration resides outside the boundaries of the Association, the submission and APPROVAL of the LOS ANGELES COUNTY POP WARNER WAIVER/RELEASE FORM is REQUIRED PRIOR TO REGISTRATION. Approval of the waiver/release requests are granted on a case by case basis and are in force for one (1) season. Waiver/Release Requests MUST be renewed annually. No candidate for registration is permitted to enroll in an Association other than the candidate's Home Association without a SIGNED and APROVED LOS ANGELES COUNTY POP WARNER WAIVER/RELEASE FORM.

- 1) Complete the Los Angeles County Pop Warner Waiver/Release Request Form in FULL. Please PRINT CLEARLY.
- 2) Provide a current PROOF OF RESIDENCE document. PROOF OF RESIDENCE can be demonstrated with a copy of a *Current Year County Property Tax Assessors' Bill* or Current Year *Utility Bill* (Water, Gas or Electric). (PHONE and CABLE BILLS WILL NOT BE ACCEPTED TO DOCUMENT PROOF OF RESIDENCE).
- 3) Submit an original and two (2) copies of the Waiver/Release Form to the Association President where the candidate wishes to register.
- 4) The following Signatures are required BEFORE THE CANDIDATE FOR REGISTRATION IS ALLOWED TO REGISTER:
  - A) The Association President where the candidate wishes to register MUST sign to accept the candidate's waiver request.
  - B) The Association President where the candidate resides MUST sign to release the candidate from the HOME ASSOCIATION.
  - C) The LAC Executive Commissioner MUST sign to acknowledge the release and waiver transfer between Associations.
- 6) Upon approval, the Original Signed Waiver/Release form must be included in the participant's team book and is required for team
