COVID – 19 RELEASE AND FULL WAIVER OF LIABILITY

In consideration of being allowed to participate in any Montague Little League (“MLL”) events or activities, I understand, acknowledge and agree to the following:

I agree to fully comply with any and all rules, regulations, terms and conditions for participation in the program, event or activity. Compliance includes but is not limited to: Practicing social distancing; Refraining from attending any MLL event when either I or a person I have had contact with exhibits COVID-19 symptoms; Wearing facial coverings when requested; Answering health questionnaires; and Submitting to pre-participation temperature checks.

I understand that I will be engaging in activities that involve risk of serious injury, including permanent disability and possibly death, and severe social and economic loss, which may result from my own action, inaction or negligence as well as the actions, inactions and negligence of others.

COVID-19: The coronavirus, COVID-19, has been declared a worldwide pandemic. COVID-19 is extremely contagious and is believed to spread mainly from person-to-person contact. It is believed that an individual can be infected with COVID-19 without their knowledge and be asymptomatic. I acknowledge the contagious nature of COVID-19 and voluntarily assume the risk that I may be exposed to or infected by COVID-19 by participating in a MLL event, related event, or activity, and that such exposure or infection may result in personal injury, illness, permanent disability, and death to myself, guests or relatives. I understand that the risk of becoming exposed to or infected by COVID-19 at a MLL approved sports program(s), related event, or activity may result from the actions, omissions, or negligence of myself or others, including, but not limited to, any MLL coaches, volunteers, and program participants.

By signing, you have read this release of liability and understand that there are inherent risks and injuries that may occur and agree to indemnify, defend and hold MLL, its agents, employees, appointed officials, volunteers, commissions, and associations harmless from and against any and all claims for damages, injuries, losses, liabilities and expenses relating to, resulting from or arising out of participation in any MLL program.
