2315 Change of Club Registration. A parent may request a change of club registration for their child at any time. All requests for a change of club registration/roster shall be submitted on-line at www.cjsa.org. The on-line form must be completed and submitted with the appropriate fee if needed. The written consent of the player's parent(s) or guardian(s) is needed, unless the player is at least 18 years of age. The CJSA Office will initiate the transfer in the CJSA Registration system. The president or Chief Officer of the club the player wishes to leave AND the President, or Chief Officer, of the club the player wishes to join must approve the transfer within the system. Or

The written consent of the Registration Appeals Board AND the written consent of the President, or Chief Officer of the club the player wishes to join.

PROPOSED:
