4.7 <u>Board Member Emeritus</u>: There shall be a category of board member known as a board member emeritus who is nominated and elected by the board of directors. Board member emeritus shall be selected from those board members who have served on the board of directors with distinction and excellence.

A board member emeritus shall be entitled to receive all written notices and information which are provided to the board of directors, to attend all board meetings, to participate in meetings, and encouraged to attend other events conducted by the organization. A board member emeritus shall not be subject to any attendance policy counted in determining if a quorum is present at a meeting, entitled to hold office, or entitled to vote at any board meeting.

Eligibility: In order to be considered for designation as a board member emeritus, a person must be a current or former board member who has:

- Served the organization's board of directors with distinction for a minimum of 6 years
- Held an important leadership role and made significant contributions
- Completed the term(s) for which he or she was appointed and/or elected

Election: Annually, the board may nominate one or more individuals for a board emeritus position. The board of directors will vote to approve the appointment(s). A simple majority vote at a meeting at which a quorum is present is sufficient to approve an appointment.
