**I understand:**

- a. It is the intent of Molalla Youth Sports to deny certification to any person who has been convicted of a crime of violence or of a crime against a person within 10 years.
- b. By applying for a position with Molalla Youth Sports or a member club, the information that I have furnished on this form is subject to verification, which includes a criminal history background check.
- c. Providing false information will result in a minimum one year suspension from participating in all related activities.
- d. Decisions of Molalla Youth Sports that result in a suspension may be appealed.
- e. My signature below authorizes Molalla Youth Sports to conduct a criminal background check.

**Incident Reports and Member Disciplinary Actions:** Molalla Youth Sports, through its Board of Directors or appointed representatives, has the authority to discipline any member, defined as a player, coach, game official, parent or guardian for behavior which is contrary to the objectives/principles (including rules of fair play) as outlined in the Sportsmanship Contract and Coaches Code of Conduct signed by all members upon participation.

Any **MYS** member displaying unsportsmanlike conduct shall be disciplined as outlined below and in conjunction with the MYS Member Disciplinary Actions SOP:

- **First Incident:** The offender will be suspended from participating for a minimum of one practice **and** game, with no refund.
- **Second Incident:** The offender will be suspended from all MYS programs for up to one (1) year, with no refund.
- **Third Incident:** The offender will be suspended up to life from all MYS programs, with no refund.
- **Fighting Offense:** The offender will be suspended for life from all MYS programs, with no refund.



## Board of Directors Code of Conduct

- I understand that the goal of Molalla Youth Sports is to provide athletics for the youth in the Molalla area to build valuable life skills for the player through the game.
- I will be an advocate for all kids. Therefore I will support all programs that are offered by MYS, and will work to make improvements as such.
- I agree to understand and abide by the by-laws, rules and policies of Molalla Youth Sports, and will work to make changes to such as needed.
- I will attend regular monthly board meetings, as provided for in the MYS by-laws.
- I will know and understand the Code of Conduct for coaches, players and parents. As a board member, I recognize that I represent MYS, its Board of Directors, staff and all programs. Therefore I will act in accordance to all Codes of Conduct set down by MYS, and will set an example for others to follow.
- I will support the efforts of the MYS office and its staff, and will provide direction and assistance as needed.
- I will recognize that as a board member, I am a part of a team. I shall always set aside personal differences that I may have with other members, and will strive to work as a team for the benefit of all kids which MYS serve.
- I recognize that I hold this position to benefit Molalla area youth, and not to serve my own interests, or for self recognition.
- When making decisions at the board level, I will always ask whether my decision benefits all kids.
- I will never use my position as a board member for my own personal gain, or for the personal gain of family members or friends.

I recognize that it is a privilege to serve on the MYS Board of Directors. I further recognize that if I break this Code of Conduct, that my offense shall be reviewed by the remainder of the board under an executive session. If the board finds by a majority vote of the members present that I have broken this Code of Conduct, I shall receive the following consequences.

First Offense – A written apology shall be issued to the Board of Directors and/or to any individual(s), team(s) or leagues that may be affected.

Second Offense – Position on Board of Directors shall be terminated as provided for in the by-laws.
