

Sports Connect Changes to the BGC Process

1. Coach/Volunteers are now able to register with your club WITHOUT completing the SafeSport/CC/SCA Certificate or a background check.
2. They will still be required to answer the legal questions and sign the ELA's to complete registration.
3. This means that once you appoint them to a team, you will be required to ask them to log back in and complete their 3 trainings and background check by going to the Volunteer Tab.

Note: if they do have their certificates, they can still upload them in this screen
