Payment will be made to individual award winners upon presentation to and approval by the Selection Committee of the following information:

- Application

- Paid receipts, or copies thereof, from the chosen school for the following items totaling the approximate amount of the award: tuition, books, fees (normal and customary), room and board (institutional housing or equivalent).
- Enrollment verification from chosen school if applicant has received a full scholarship and no receipts are available.
- Any other documentation of significance.

In lieu of paid receipts, payment may be made in the name of the recipient to the college or university.

Use, or attempted use of awards for other than the stated purpose shall be grounds for revocation and forfeiture.

Family members of the Selection Committee are not eligible for awards.

Note: Failure to comply with, or follow specific instructions will be grounds for disqualification of the application.

Applicants will be notified of the Committee's actions and final decisions.

The 3&2 Baseball Club of Johnson County Scholarship

This fund was established in 1987. Its purpose is to offer scholarships providing financial assistance to qualified graduating high school Seniors while attending college. They must be residents of Johnson County who have actively played on a baseball team participating in league play at the 3&2 Baseball Club or otherwise been employed by 3&2 Baseball Club as an umpire, concession employee, ground crew, gate crew or in some other capacity.

Any accredited university, college, community college or vocational school is an acceptable institution for the purpose of these scholarships. This is a one time only award and its intended use is for tuition, books, fees, room and board.

For the current year, the amount will be:

\$500.00

Applicants must demonstrate high moral standards and be of good standing in the community. Awards will also be based upon academic record, class ranking, and work experience, if any; have a record of past or present participation in non-curricular school and/or civic/community activities; and have a final grade point average of 2.5 or higher.

Selection will be made by an independent committee appointed by the President of 3&2. This committee shall have exclusive authority in determining to whom awards are made.

Applications and supporting documents must be received no later than February 14 of the current year.

All junior and senior players are urged to take advantage of this unique opportunity offered only to those participating in the 3&2 program each year.
