



Release of Liability and Hold Harmless Agreement

PLAYER RELEASE AND WAIVER OF LIABILITY AND INDEMNIFICATION AGREEMENT

1. In consideration of being allowed to participate in any way with Foothill Little League, and in events, and for Little League International, and its related events and activities, including games, practices, and any team organized event related to Foothill Little League.

2. I, the undersigned, acknowledge, appreciate, and agree that: The risk of injury to my child from the activities involved in this program is significant, including the potential for permanent paralysis and death, and while particular skills, equipment, and personal discipline may reduce this risk, the risk of serious injury does exist; and,

3. I am aware of the Covid19 pandemic, I understand that the virus exists and is potentially contagious. By having my son play in organized tournaments and on teams comprised of 9 to 14 kids playing in against other teams similarly composed, and at tournaments with 20 to 500 people, there is a risk of infection to my child, and people my child comes into contact with, due to contact with someone who has the Virus while My child plays with Foothill Little League Baseball. I am specifically aware of this risk and agree to accept the risk. As my Child's guardian I am allowing him to play in Foothill Little League and the tournaments entered by Foothill Little League knowing the risk of infection to my Child and the people my Child contacts. I understand while Foothill Little League Coaches and Management will attempt to have some protocols to minimize these risks, that social distancing on a baseball field and dugout is virtually impossible, that kids often violate protocols, and there is no way that anyone affiliated with Foothill Little League can prevent infection from any virus.

4. I am aware that Foothill Little league will conduct baseball practice's and games. If I ask that my son be transported in car by a parent of another player, coach, or manager of Foothill Little League to get to a game or practice, I understand that if I give such permission for such transportation that I am waiving any claims or actions due to the negligence of any driver affiliated with Foothill Little League.

5. On my behalf of my child, _____ I KNOWINGLY AND FREELY ASSUME ALL SUCH RISKS, both known and unknown, EVEN IF ARISING FROM THE NEGLIGENCE OF THE RELEASEES or others, and assume full responsibility for my child's participation; and,

6. I willingly agree to comply with the stated and customary terms and conditions for participation. If, however, If I observe any unusual significant hazard during my presence or my child's participation, I will remove my child from participation and bring such to the attention of a Foothill Little League Board Member or any associate immediately.

7. I, for my minor child, and on behalf of my and his heirs, assigns, personal representatives and next of kin, HEREBY RELEASE, INDEMNIFY, AND HOLD HARMLESS, Foothill Little League, Foothill Little League Manager, any Coach or associate of Foothill Little League, Little League International, their officers, officials, agents and/or employees, other participants, sponsoring agencies, sponsors, advertisers, and, if applicable, owners and lessors of premises used for the activity INCLUDING BUT NOT LIMITED TO FOOTHILL LITTLE LEAGUE, The City of Ventura, , and all other facilities used by Foothill Little League ("Releasees"), WITH RESPECT TO ANY AND ALL INJURY, DISABILITY, DEATH, or loss or damage to person or property associated with my presence or participation, WHETHER ARISING FROM THE NEGLIGENCE OF THE RELEASEES OR OTHERWISE, to the fullest extent permitted by law.

I HAVE READ THIS RELEASE OF LIABILITY AND ASSUMPTION OF RISK AGREEMENT, FULLY UNDERSTAND ITS TERMS, UNDERSTAND THAT I HAVE GIVEN UP SUBSTANTIAL RIGHTS BY SIGNING IT, AND SIGN IT FREELY AND VOLUNTARILY WITHOUT ANY INDUCEMENT.
