- Thanks to all volunteers, coaches, parents, kids for making the 2025 baseball season a success
- Special thanks to the 2 full-time concession volunteers Jill and Jaime the concession stand will have profit of about \$20k for the 2025 season (spring, tournaments and fall)
- Below are some projects, upgrades, new items that were completed this season
 - Repair to field 5 backstop to force water out of home plate area and to drain behind instead
 - Hot water tank and sink in concession stand
 - New plumbing in toro garage (garage behind field 2)
 - Fields 1, 3 and 4 regraded
 - Flag pole and memorial behind left field of field 2
 - AED in concession stand and in field 4 shed
 - New turf in Cecil Elementary batting cage and in the cage by fields 3&4 (turf donated by W&J College)
 - New scoreboards for fields 1, 2 and 3 installation of these has yet to happen
 - New field signs for all 5 fields
- Projects we hope to complete in 2026
 - New LED lights for field 1
 - Blacktop the parking lot entrance where there are currently 2 potholes
 - Millings for parking lot
 - Installation of 3 new scoreboards as mentioned above
- We are forming a Special Project Committee
 - We will be working with someone who has experience in getting grants/sponsorships to help us with the costs of big upcoming projects
