- III. Approval of Previous Minutes: Motion made by Bob to approve the April minutes. Jacob seconded the motion. No votes against approval.
- IV. President's Update: Jacob Larkee
 - a. D5 Update: At recent district meeting, Administrator focused on getting everyone to follow the rules (ie. Will not sign tournament affidavits until everyone has paid bills and have safety plans in place.)
 - b. 2026 Executive BOD and Advisory: 5 applicants received to date. If BOD members are interested, please submit applications. BOD members are encouraged to talk to parents and encourage them to get involved.
 - c. Fall Season Proposal: Small, capping divisions at 40 players. Focused on younger players to get another season of baseball. End October 11.
 - i. Kameron or Jodi will look into if Denver Athletics has dri fit shirts in stock that they can print quickly.
 - ii. Jacob looking into how we would have players register.
 - iii. Nick discussed having pitcher and catcher dedicated sessions in fall ball, where players may register and pay extra for these dedicated sessions.






