What are Committees?

- The BOD shall have the power to appoint such standing committees as it shall determine appropriate and to delegate such powers to them as the Board shall deem advisable and which it may properly delegate.
- Regular Members, and Appointed Board Members are allowed to be on a Committee but are not permitted to
  vote on specific policies or procedures.
- Executive Committee
  - Who: Not less than 3, nor more than 5 Directors, one of whom shall be the President of the Local League
    - President, VP Baseball, VP Softball, Secretary, Player Agent (Kameron)
  - Purpose: The Executive Committee shall advise with and assist the Officers of the Local League in all matters
    concerning its interests and the management of its affairs, and shall have such other powers as may be
    delegated to it by the Board, but in no event will the Executive Committee have authority over the Board of
    Directors
  - This was used a bit in the beginning, but not much as the year went on.
  - Committee Chair: President
- Finance Committee
  - Who: President, VP Baseball, VP Softball, Treasurer
  - Purpose: To investigate ways and means of financing the Local League including team sponsorships, fundraisers, creating a budget, etc.
  - Committee Chair: Treasurer
- Audit Committee
  - Who: Adam, Mallori, Bob
  - Purpose: To review and approve monthly financial statements prior to the monthly BOD meeting
  - Committee Chair: Bob


