# **West Plains Little League**

West Plains Little League is a 501c3 non-profit corporation (Tax ID 20-0508524) that was formed in 2004. The league was created to promote baseball and softball to boys and girls in the Airway Heights, Cheney, Fairchild AFB, Medical Lake, Spangle, Reardan, Davenport communities. Currently, programs are offered for children between the ages of 4 - 12. Consistent with the National Little League Charter, all board members are volunteers; there is no paid staff.

In order to promote the game of baseball and softball in an effective and healthy environment, WPLL requires funding for equipment, uniforms, umpires, field maintenance, etc. Each player is charged a nominal fee to play; \$50 - \$100 depending on the level of play. This fee is nominal by design, as it is the mission of WPLL to make sure every child who wants to play baseball / softball has that opportunity. All other "operating" money is generated via sponsors of the league.

## **Sponsorship Levels**

Division Sponsor (\$1,000.00) – Division Sponsors help support an entire division of either tee ball or coach pitch. Division sponsor logos are placed on every player jersey within their division. There are usually 8-13 teams in each division. They also receive a banner at our Salnave Baseball fields, recognized at all league events and on social media. They also receive a plaque to display in their business.

### Team Sponsor (\$700.00)

Team sponsors have a team named after them; example XYZ Corp. This team is referred to as XYZ throughout the season on all scheduling and team lists. They will also benefit in the following ways:

- The company banner will be hung on the dugout during each game.
- They will be listed on the WPLL website and in various brochures.
- They will be recognized during Opening Ceremonies.
- They will receive a plaque to hang in their business with a picture of the team.
- A company banner will hang on both outfield fences at the Salnave baseball fields during the season.

Majors Baseball	6 to 8 Teams	\$700.00 per year
AAA Softball	4 to 5 Teams	\$700.00 per year
AAA Baseball	8 to 10 Teams	\$700.00 per year
