- I. Call to Order: The meeting was called to order by President J. Castellano at 7:14 pm. A quorum was present.

President Report – J. Castellano

Too often, someone in charge of a job/task drops the ball, and it has to be picked up by other board members who already have a lot on their plate. If you volunteer to take on a job, make sure you can put in the time to do it or, if necessary (on occasion), delegate to someone else who can cover accordingly- but not on a regular basis.

Treasurer Report - **S. Spencer** – We are at \$104K right now. Have started to pay some bigger invoices (Largus); Uniform invoices are still not in yet- that will be a big one. In a good place.

District 1 Report – J. Castellano

Rich had surgery on his eyes, having issues- cancelled the in person meeting and moved it to Zoom. We were unable to make it. John called Rich to find out District dates- which are not ready- but we can assume around the same time as last year. State dates for 8-10 and 12s: July 20-25; 11s: July 14-19 (Wabash).

V. Challenger League Update- B. Matthews

-Have 43 registered so far; \$3043 is the current budget- pay Town, Concessions, Shirt/Hat for all players. -Looking for a bead/bean baseball for visually impaired players. Maybe try Wilson.com; or reach out to the District 1 Challengers liaison.

Would HAVE to open it up to everyone in the district- can't pick and choose who would play in the tournament.

VIII. Substitution List Discussion

- John and Gordy discussed; the rule came about due to Covid; let the substitution list ran free; less and less kids are missing games now; Player Agent is supposed to maintain the list of eligible players- says once you sub, you can't sub again until everyone else on the list has subbed. Majors division can pull the same Minor league player up to 5 times to play up.
- At this point, not a whole lot to go into unless it comes up; teams should try to sub for around the same player level/draft pick, if possible.

All schedules are out; have only had a couple of requests to move Tball game up to be a little earlier; hoping to have potential makeup dates sent out to managers so they have an idea of what to plan for should games be cancelled.

- Rick wants a raise; claims that they haven't received one sine 2021, but we did give one for Majors and Minors games in 2022
- Proposed by Rick: \$100 for Majors; \$90 for Minors; \$75 for C League; counter with a \$5 raise in each for Spring (\$95/\$85/\$70) and they'll get another \$5 in Fall Ball (\$100/\$90/\$75); then the new rates will stay in place for all of 2024 (Spring and Fall). John will go back to Rick with this.

XVI. Equipment Update – J. Castellano

-Still having issues getting catcher's equipment; need to go to Amazon to buy more (can't find locally); need to give 3 more teams their equipment and then all will be good.

XVII. New Business – J. Castellano

- Batting Cages: Need to get a quote for new L screens and new netting (for at least 3 of the cages)
- S. Spencer makes a motion to spend up to \$2,000 for 4 L Screens; K. Dempsey 2nds; motion passes unanimously.

XVIII. Adjournment – K. Dempsey motions to adjourn at 8:42 pm; A. Keefner 2^{nd's}. Motion approved.
