Potential out of town players: John has been working on this; spoke to Rich Arent. HLL President would need to agree to it and District #1 admin (Rich) would need to approve, and LLI would also need to be approved.

Do we need to fight for the one kid that has asked to get in? Opinion of the board is that we will not let him play, because if you let one in we will have to let more/all in.

Asked, in what situation would be able to take out of town players?

-Will need to filter out the out of town registrations this year- especially the ones that play Fall Ball in Munster.

VI. AED/CPR Certification Discussion - J. Castellano

CPR Certification- there is a nominal fee (about \$15); can do it online or hold a class to do as a group.

- -We can't make people get certified and it might be useless, but it is best to offer it to the managers/coaches if they want to do it and we reimburse them. We are doing our part to help prepare people, if needed.
- -Rick will look into setting up classes and how much it will cost to hold one or two sessions

Majors- Mondays/Wednesdays/some Saturdays

Minors- Tuesdays/Thursdays/some Saturdays

C League- M-Thursday and Saturdays

Fridays are to stay open for rain delays

- -We need to schedule games in April much more- even with weather that is not as nice; need to reschedule games quicker
- -Takeaways from 2022 scheduling: pushback on late games in April; since Prep and TBall don't start a couple weeks later, spread out the older divisions to 1 week day game and 1 Saturday game- to eliminate a late game during the week when it is colder in April.
- -Have a FIRM stance at Manager's meeting about rainouts and make up games so they are aware and know what to expect during the season

Use A, B and D on same days for Majors and Minors games- we could, the problem is having enough umpires available. We can talk to Rick about getting more, if possible.

XIV. Umpires-J. Castellano

- -Rick has not mentioned anything about a raise this year; we gave a substantial one last year
- -Would like MLL to pay for an umpiring class for him to attend to re-certify and brush up on new rules, etc.

XVII. Special Events- A. Rubio

-Would like to do an end of the season party/BBQ; jump houses, dunk tank, etc.
