John, Dan, Gordy, Ray and Adam met on 11/6 at Danny Z's to discuss the 2024 budget. Expecting an income of \$151K with expenses around \$149K. A surplus of \$1600. Looking Jan-Nov 2023, it looked like we took a loss, but not including the registration money that will come in in December.

Need receipts for all purchases MLL is expected to pay.

## VI. 2024 Budget Discussion –

Special events budget for 2024- \$2K . We would like to up the budget to \$3K. **Board approved**.

Raising the fees for Spring and Fall in 2024.

- Have we ever heard any push back on the fees from parents or families? No, not really. But, we have to offer a full season (18 games for Majors and Minors, for example) and we are up against District tournament dates starting sooner and sooner. We run the risk of not being able to finish a full season.
- R. Petrocelli- it's a risk not to raise fees- due to inflation. The goods we use are up 40-80% and we run the risk of hurting ourselves financially if we don't.
  - Prices from Tball to Majors are too close compared to what they get. Maybe we bump up the Majors/Minors/C League.
  - Raising the fees \$10 not a big deal. If we want to do capital improvements, we need to have more in reserves and generate more revenue.
  - Raising prices in small increments is easier- as long as you aren't going over a large threshold.
  - Having 3 months of operating expenses would be nice to have- \$36K?
- George to put a Google form in the chat to do a vote on whether we need to raise the registration fees. Results: 12 total participants: 8 yes to raise prices. 4 voted to not raise prices.
- DO we raise them significantly this year and not raise them for 2025. Or just raise them for 1 year and revisit next year? Hard to say now that we won't need to raise next year.
- Another Google form to vote on how much to raise prices per division. Proposed pricing:

- o Tball: \$165
- Prep: \$175
- o C League: \$200
- o Minors: \$220
- Majors: \$230 (\*2 umpires per game)

Vote to change the budget to include the price changes above and add'I special events budget by \$1K; G. Souri; R. Petrocelli 2nds; motion approved.
