- C-League: Section IV. 7. B. 2- revised language regarding substitutions to match previous rules: R. Petrocelli motions to approve, M. Bruni 2nd, Motion approved.
- C-League: Section IV. 4. E.- Revised language, removing ambiguity of the halfway rule and allows two base limit on outfield hit; Allowing ultimate discretion for umpire: J. Jamicich motions to approve, R. Petrocelli 2nd, Motion Approved.
- C-League: Section IV. 3. J. Motion to change the mound distance from 43 ft to 40 ft. R. Petrocelli motions to approve, G. Souri 2nd, Motion approved.
- C-League: Section IV. 3. Pitching rules would remove any walk restrictions, and 7YO & 8YO have the same pitching guidelines. K. Adley motions to approve, G. Souri 2nd, Motion approved
