Meeting called to order by Doug Wallis at 6:37pm

I. Approval of December 2021 Minutes – Kasey Rey motioned to approve the December Minutes with a couple spelling and formatting corrections. Wendy O'Brien seconded. Approved.

II. Club Business

- 1. Facilities / Fields update None
- 2. Winter Futsal- 12 Teams are playing. The first weekend of play, a couple moms were upset with the required mask wearing in the Student Life Center at Ft. Lewis but that has been resolved. A couple doors in the boy's bathrooms were kicked and dented. Not certain who caused the damage but Kate offered to pay for the damage, but hasn't heard anything yet. Kate sent an email to each team contact to address the door vandalism. There were no issues this past week. Financially, the club is roughly breaking even. Overall, players are having fun.
- III. Executive Director Report— See Attached. Kate met with Mercy Sports Medicine and secured a \$4000 cash donation and \$1000 in kind. The club is considering framing a practice shirt or jersey to give to sponsorship organizations to hang in their places of business.

New Mexico is questioning if Colorado Soccer Club teams should be allowed to play in the New Mexico League? Kate talked to Nate at Colorado Soccer and there has been an official signed agreement for years between CO and NM. Unsure why this issue is coming up now. For now, we have permission to continue to play in the New Mexico Leagues this Spring. Re: future seasons, Nate is going to work out the details with Gloria in New Mexico.

Doug mentioned that our teams need to be prepared to follow the Covid masking rules in other states and locations. The club will provide each coach with a box of masks. Managers will remind parents to comply with Covid policies when travelling to other areas to play.

- a. U9-U12--Joanna Tucker- All teams are covered with a coach and an assistant. A few female college players had to back out of assisting due to scheduling conflicts. Pre-season emails have been sent to encourage coaches to connect with their teams. Joanna is reinforcing the importance of communication and connecting. Practice to begin at the end of February. Some teams will start practice a little later to stay within budget constraints since their league play starts a few weeks later. A list of coaches names and managers names will be shared with the Board.
- **b.** U13-19--Jimmy Hall Jimmy is also connecting with his coaches. He is working hard to bring on John Berzins. He has a skill set that the club could benefit from. The 07' age group coaching configuration still needs to be finalized. Aaron Champenoy will coach the older High School Group. The middle HS group will be coached by Zach Keeler and Dylan Connell. Jimmy will coach the younger teams and is trying to find a 2nd coach. The college recruiting video is almost complete and will be distributed to those HS players interested in

playing at the college level. Jimmy is working on finalizing teams in leagues. Several girls are utilizing the club pass to guest play with other teams and those experiences have been very positive and beneficial.
