Any reference to the Sponsorship under this agreement must make it clear that the Sponsorship is with the West Oak Little League ONLY, and NOT with Little League Baseball and Softball, the organization. Use of the marks and/or logos of Little League Baseball and Softball by any local sponsor is prohibited, unless permission is expressly granted in writing by Little League Baseball, Incorporated.
