#### 1. Welcome

## 2. Bat changes for 2018

- a. We discussed urgency to police bat compliance at every practice, game and event.
  - i. All illegal bats must be removed from field and put outside the fence during play.
- b. League could be held responsible for an injury caused by illegal bats
- c. Recommendation: Ensure a Board member is present for all practices and games at the beginning of the season.
- d. Information:
  - i. Add notice on Website and include picture of USA approved sticker
  - ii. Facebook posts to include notice and picture of sticker
  - iii. Email blasts weekly until season begins
- e. Recommendation: Bat Demo Night
- f. Future discussion: which bats will league put in team bags?

#### 3. Snack Shack

- a. One of our sponsors has stepped forward with a potential interest in running the snack shack.
- b. Question: Who is going to cook? Do we need burgers?
- c. Recommendation: Use Square or some POS app for ringing up and tracking purchases
- d. Recommendation: Sign-up for parental coverage of Snack Shack; however, mentioned that may add a challenge to consistency and expectations.
- e. Recommendation: Form Snack Shack Sub-Committee

#### 4. Fundraising

- a. Adam starting to organize documents and prepare business plan.
- b. Move away from direct mail; move more to online presence, electronic option
- c. Get sponsorship requests out to existing sponsors first.
- d. ETA: sending out first requests by end of October.

### 5. Constitution Discussion

- a. Need to add a line in there to call out updated name of Rutland Baseball & Softball, but for now it remains Rutland Little League (officially)
- b. JP will send out revised version for final sign off from Board.
- c. Correction: update majority voting to 75%
- d. Update Bank
- e. Motion Carried to add Player Agent to Executive Committeer to make it 7 people.

# 6. Registration Fees for 2018 Season

- a. Recommendation to keep fees the same for 2018 as fees were increased in 2017.
- b. Eric mentioned that he may not know Softball fees until January, but Jonathan stated we could cover the additional costs for 1 year and then reassess next year.
- c. ETA: Open Registration by November 1st.
- d. Recommendation to get notices out to each of schools that Registration period will be open.
- e. Keep registration period November 1<sup>st</sup> January 31<sup>st</sup> (Late Fees start in February)
  - i. Name initial period as "Early Bird Special"

- c. Evals typically weekend of St. Patrick's Day. May need to move up 1 week (3/10/18)

- c. Permanent batting cages for Naquag and Central Tree
- d. Additional items
  - i. Softball Wishlist: How to make the experience better for Softball?
    - 1. Lights at the 2 fields have been turned down
    - 2. Electricity for a Scoreboard
    - 3. Storage for concessions
    - 4. Batting cage
    - 5. At a practice field (we'd need help from town)
  - ii. Softball teams cannot play on baseball field due to outside issues and pending lawsuits around state.
