- Sequoia permit issue
 - Exclusive to NPPB prior to covid, post covid went to a booking system
 - Tues/Thurs taken by an outside travel team
 - Insurance needs to be updated to cover longer term to enable permit booking earlier
 - o Bathrooms and trash, etc all paid for by us, not this new party
 - We will be putting new locks to avoid equipment issues
 - Del Prado 3 is secured, will need to discuss what division makes sense to use this field





- Unpaid balance list
 - Around \$6.000, some noise in the report
 - Need to go through and decide what to take action on
 - Those with small balances for changing divisions in prior seasons may be forgiven
 - Boris is receiving some checks
 - o Those that we don't receive payment from will be followed up by Boris and Mark
 - o Recommend holding uniforms for players that haven't paid

Operations Director Report - Tyler Smith

- Fences supposed to be installed at DV last Friday 2/2/24
 - We do have permits, but fields closed due to rain.
 - Hoping for Friday or Saturday at the earliest
 - Working to see if we can get fences at Cypress
- Field day Feb 24th and 25th
 - Will need to have a small group working on mounds
 - More information to come
- Field PREP Training at the end of the day Sunday 2/25/24 (5 or 6pm)
- Shetland and Pinto fields construction box to hold equipment closer to the fields
- Half scoreboards are up and running, working on the others to be working by opening day
- New hoses last year, hose for each field. Mustang has deeper box and has specific hose for it. Tyler will be labeling
- Gater maintenance in the next week or 2
 - Cypress gator has a flat tire

Treasurer's Report - Boris

- 3 accounts
 - Main
 - Balance \$134,574.46 due to registration revenue
 - \$119000 incoming so far, looking for additional transfers from registration
 - Snack shack
 - Balance \$1600, we will transfer to this account to be able to purchase inventory
 - Aware of food increases this year and last
 - Money Market Savings
 - Balance is \$45,500 down from \$75,800 due to improvements
- Outstanding balances / Upcoming expenses
 - Registration balances due
 - Umpire fees
 - Permits costs
 - Consider increasing costs for 60/90 at various fields
- Last year after all expenses we made \$2,417 profit
- Possible revenue generators
 - Additional tournaments with Huffman needs to be strategic choice not revenue choice
 - Room to increase fees (Market research shows we are down comparatively)
 - o Interleague revenue in the future, commitments from our partners
- Recommendation to pause from capital spending (special projects, improvements, etc.)
 - Until savings is back to where it was in the past





Be mindful of capital requirements needed for insurance etc.
