Standard PIAA Rules with the following addendum:

1.0 Gym Rules

- Games must begin on time
- Note: Coaches are responsible to obtain the clock, score book, etc. from the closet and enter lineups in the score book before the start of the game.
- Must exit gym immediately following the end of your game.

2.0 Quarters – Four 8 minute quarters with running clock

- Regulation 5 minute halftime, clock stopped for free throws and timeouts, and for all stoppages under one minute in the 2nd quarter and under two minutes of the 4th quarter.
- Overtime
 - Two (2) two minute overtimes to be played in case of a tie during the regular season. If game is tied after the 2nd OT it will remain a tie
 - Playoffs Playoff games will use additional overtime as required until a team wins the game

3.0 Time Outs - Four (4) one-minute time-outs per game / Two (2) per half

- Time-outs do not carry over from first to second half
- Additional one (1) time-out per overtime period
- Time-outs cannot be carried over from regulation to OT(s)
- Playoffs: Time-outs cannot be carried over to additional OT(s)

4.0 Fouls

- Players are disqualified on their fifth (5th) foul.
- One and One will be shot after the seventh (7th) foul of each half
- Two shots after the tenth (10th) foul of each half
- Fouls from the second half are carried into OT
 - Note: Player is removed from game after their 5th foul. The team can continue playing with less than 5 players

5.0 Defense

- Zone and half court man-to-man defense is allowed at any time
- Full court pressing is only allowed in the final two minutes of the game and overtime
- FAST-BREAKS: No team can fast break when they get a defensive rebound, but they can get a fast break on a steal, blocked shot or turnover
 - The team who is defending the fast break is allowed to apply pressure at any point once the fast break has been established (referee discretion on whether a fast-break has been established)
 - The offense must be allowed to proceed un-defended until half court when the ball is brought up without a fast break attempt

6.0 Games start with a jump ball - then alternate possessions

- A team may begin the game with 4 players as additional players arrive they may be inserted into the game and scorebook without penalty no technical foul will be accessed
- All OT periods start with a jump ball

7.0 All players must play a minimum of half the game

- Each player must also sit at least once (4 mins)per half. This does not apply if there are less than 7 players.
- The clock will stop with four (4) minutes left in each quarter for subbing purposes. In the last 2 minutes, you may sub freely at any stoppage.
 - It is the coach's responsibility to enforce this rule

8.0 Technical Fouls:

- A player or coach will be ejected after two (2) technical fouls. The ejection will be reviewed by the commissioner and basketball committee and further suspensions may occur. A technical foul will be called on a coach who has used all timeouts and attempts to call timeout again.
- Any player ejected from a game will be suspended for an additional game. A second offense will result in suspension for the remainder of the season
- Coaches are allowed to stand to call time-outs, call plays, etc. but at no time should be confrontational or talk to the referees.

9.0 Standings: By win percentage/win-loss record

10.0 Playoffs

• Players must play in a minimum of 1/2 of the teams regular season games to be eligible for the playoffs - exception is injury - coaches are responsible to notify the Commissioner if this

exception occurs within one day of the scheduled game - only players at the game should be listed in the score book.

11.0 Tie-Breakers: In case of tie in playoff seeding:

- 1. Head-to-head record
- 2. Total points for in regular season
- 3. Lowest total points against in regular seeding
- 4. Coin-toss
