 - IX. **Fields & Facilities –** Fields wont be used to the east of South MS. Potential to schedule the championship games at Cushman Field, Mike will look into this.
 - X. **Team Manager Coordinator –** Nothing really to report besides the issue getting friendlies.
 - XI. Out of Town Tournament Coordinator Need to finalize what teams are playing at the C2 level, not C3. Will discuss with coaches at the meeting before Tri-City tourney and will have chance to adjust after the meeting if they things need to change. Miranda will get teams registered after that.
- XII. Recreational Coordinator Matt shared the GF Park District will link our registration and store nets. Also, they won't charge us for fields per player next year for the age groups we are taking over from them, to help keep the cost at the level it was. We will draw up what we want Bringewatt to look like in the fall after the season and they will spray the new lines in the spring of 2020. Dragan will be retiring soon and maybe we should approach Camden about taking some sort of leadership responsibility moving forward. Matt will work on getting registration open by July 15th with a soft close of Aug 24th. Goal will be to have rosters set by Aug 30th and practices will start Sept 3rd. Games will start Sept 14th and season closes Oct 12th.
