Law 5 - The Referee	There are no referees in this division. The game will be managed by up to one coach from each team with an emphasis on the development of skills and an explanation of the rules when calls are made.	There are no referees in this division. Law 6 - Assistant Referees	Assistant referees are not used in this division.

Law 8 - Start of Play	A kick off starts play to begin the game, after each quarter, and following a scored goal. The ball can move ANY DIRECTION and may not be retouched by the kicker until any other player touches the ball. A goal may be scored directly from a kick off.	
Law 9 - Ball In and Out of Play	The ball is out of play when it has entirely crossed the sideline or end line and when play has been stopped by the referee/coach. Any ball striking a referee/coach, goal post, or corner flag while remaining on the field is in play.	
Law 10 - Goal Scoring	A goal is scored when the ball entirely crosses the goal line between the goal posts and under the cross bar.	
Law 11 - Offside	Offside is not an infraction in this division. However, we don't want coaches to intentionally put playes in an offside position.	
Law 12 –Fouls and Misconduct	An indirect free kick shall be awarded for the following: • Handling the ball • Tripping • Striking an opponen • Sliding at an opponent • Pushing The coaches may choose not to call the infraction if the	Charging from behind
Heading:	Heading is no longer allowed for this age group. An indirect free kick will be taken at spot of the infraction on an intentional header.	
Law 13 - Free Kicks	All free kicks are indirect and opponents are at least 5 yards from the ball until it is in play. The ball must be stationary when the kick is taken and the kicker does not touch the ball a second time until it has touched another player. If the free kick is kicked directly into the opponent's goal a goal kick is awarded. If the free kick is kicked directly into the team's own goal a corner kick is awarded to the opposing team.	
Law 14 - Penalty Kicks	Penalty kicks are not awarded in this division. An infraction inside the goal arc will result in a indirect free kick 5 yards outside the arc / goal box.	Penalty kicks are not awarded in this division. An infraction inside the goal box will result in a indirect free kick from the penalty spot outside the goal box.
Law 15 - Inbound Kicks & Throw-ins	After the ball has entirely crossed the sideline, the team not last touching the ball shall be awarded a kick-in. Kick-in regulations: A kick-in is considered as an indirect free kick with opponents 5 yards from the ball until it is in play. Law 16 - Goal Kicks	A goal kick is awarded when the ball passes entirely over the end line but not within the goal scoring area and is last touched by an offensive player. The defending team makes the goal kick. The goal kick should be taken anywhere within the Goal Arc or Goal Box area. Opposing players must retreat to mid-field until the ball is in play . The team in possession of the Goal Kick may receive a pass within their own Arc / Box.	
Law 17 – Corner Kick	A corner kick is awarded when the ball entirely crosses the goal line and is last touched by a defensive player and is not a goal. The ball is placed inside the quarter circle at the nearest corner. An offensive player may then kick the ball The kicker may not touch the ball a second time until after it is touched by another player. A goal may be scored directly from corner kick. The opposing team must be at least 5 yards away. A goal may be scored without another player touching the ball.	
Goal Box	A player may not be within the Box that surrounds the front of the goal until the ball is also inside the Box. If a player is within the Box, they will be asked to leave. If they do not leave, the opposing team will be awarded the ball in either the form of a Corner Kick for the offense or a Goal Kick for the defense. Coaches are urged to remain in the "spirit" of "Fair Play" and not to try to use this rule to their advantage. The intent of this Law is to get the players into the game in the middle of the field and not "camping" in front of the goal. PLACING A STATIONARY DEFENDER ON THE EDGE OF THE BOX IS HIGHLY DISCOURAGED.	
Local Rules:	 An emphasis is to be placed on fun and development. All players and coaches should use the team area between fields during the games. Spectators should be on opposite sideline. Scores are not recorded, but coaches are encouraged to move players between the two teams in their POD in order to keep all games as competitive as possible.
