#### **Review draft of new Constitution**

Changes will be made to the following Articles

- (1) Article III Membership, Section 2, b
  - Modify definition of a member by adding \$5 membership fee and remove automatic membership for volunteers

Regular Members - Any adult person actively interested in furthering the objectives of the Local League may become a Regular Member upon election and payment of dues (\$5) as hereinafter provided. Regular Members may be issued a card numbered in sequential order annually. The secretary shall maintain the roll of membership to qualify voting members. Only Regular Members in good standing are eligible to vote at General Membership Meetings. All Officers, Board Members, Committee Members, Managers, Coaches, Volunteer Umpires, and other elected or appointed officials must be active Regular Members in good standing. Note: Regular Members of the league automatically include all current Managers, Coaches, Volunteer Umpires, Board Members, Officers of the Board, and any other person who is recognized by the Board as a volunteer in the Local League, including the following volunteers titles listed below: Recommend Positions: Team parent, Equipment Manager, Coaching Coordinator, Sponsorship/Fundraisers Manager, Information Officer, Groundskeepers, Concessions Manager, Umpire-In-Chief etc...

- (2) Article V Section 7
  - Change "Upon the written request of a minimum of five members," to "Upon the written request of a minimum of twenty members."
