5) Reports of Committees

- a) Fundraising (Katrina Rausenberg, Matt Rausenberg):
 - Sponsorship fee structure
- b) Concessions (Lahanna DuFour, Jerika Zuckerman):
 - Heat shield needs to be installed (Kyle)
 - Training video for open/close procedures (Lahana, Jerika and Cynde) Tabled till next season
 - Door and threshold replacement (Chris)

We received a \$3,000 donation from DuFour family for this repair which has already been placed in savings.
