## **III.** Unfinished Business from Last Meeting:

## NJYS Call to suspend all activities until at least April 1:

Mike Majorczak suggests starting training and practices on 4/6/20 if allowed by CDC and NJYS. This would apply to all Levels in the Club. First weekend of Instructional, tentatively 4/11 – 4/12. Travel games per MNJYSA, ICYSL games per ICYSL and EDP games per EDP.

The above are all tentative pending NJYS and CDC directions.

**UPDATE:** CDC and NJ Governor Murphy has extended the quarantine to 4/30/20.

## 1. Ginny Caputo has expressed interest in the Club Historian/Statistician board position:

Club Historian/Statistician— would be responsible for pulling information from our own data pool and information that different leagues already provide. Motion by CM, second by JW, to create a new Board position that is appointed by the president, and might be used to provide the below feedback to the rest of the Board.

- Duties:
- i. Help measure the club's successful. Is the PSC improving?
- ii. the number of players each season (Brian may have info that could allow us to create estimates going back as far as he has records
- iii. show trending of Club, and its programs (Little Kickers, Instructional, ICYSL, Travel, EPD teams)
- iv. help understand player retention (survey those who don't come back? Moved away vs. went to another club vs. ...
- v. the average number of goals scored per team last season (then trend)
- vi. the average number of wins ...
- vii. list of players that went on to play in college
- viii. Number of coach licenses (F, E, D...), assistant coach licenses, for the club, vs. by program. What other training has a particular coach taken?
- ix. Trophy Case (virtual), a historical listing of the awards and tournament 1st & 2nd places, including a picture of the trophy or Medal
- x. Team Stats historical view, same coach? same trainer? what flight where they 2 years ago?... I have a mock up
- xi. Club Stats can we somehow measure the PSC to surrounding clubs? (# teams? # teams in EDP? we use a training org but do they?)
- xii. Player Evals If we started this (have our training org give an evaluation once a season, or at beginning and then at the end of each season), can we see trending by player? Who is getting better? are they where we want them to be? who isn't there? Can we offer them extra training?
- xiii. Budget analysis At the end of the year (2 seasons), with all of the issues that come up (ex the coach just left us mid-season, so the board votes to pay a trainer to take over at club's expense) did

we still meet our budget? or what was the overrun. Think of an annual report which could include other stuff as well (what is our inventory of paint machines, portable lights, goals, benches,)

**March:** PSC board votes to accept this nomination by a vote of 6 yes, 1 abstain. The new board member will be added to the BOD listing and website for April 2020.

**COACHING LICENSE** - Team Head Coaches and Team Assistant Coaches shall obtain a minimum National or State License prior to the start of their second (2<sup>nd</sup>) season (either Spring or Fall) of coaching, unless the Affiliate Association in which such person coaches, has stricter requirements. The club will reimburse the cost of any fees incurred by a Team Head Coach or Team Assistant Coach in obtaining any National or State Soccer Coaching License. The license required shall be determined by the age of the youth players being coached:

- a. Players under 11 years of age "F" Level Coaching License
- b. Players 11 19 years of age "E" Level Coaching License
