- A. Registration 2014 – Discussed registration. In lobby, there will be two lines, Pre-registration, and all others. Pre-registration will check in, and get their form and other papers in folder. All others will check in and get their folder with papers. All players must go to Uniform, Volunteer, Fundraiser stations. At Uniform, pre-reg forms will be checked for accuracy. All others will get a form filled out with correct size. Then folder stamped and initialed. All players must decide on Volunteer time, and have folder stamped. Then all players must decide on Fundraiser/Cardinal night and have folder stamped. At this point, pre-registrations can choose to go to Manager table and then Sponsor table or, if they have no corrections, they can go directly to check out with Rita. They can have their checks ready and drop off, or pay Rita. If pre-reg have changes, then they must see another check out person to fix the sheet. Each table will have a stamp to show that they went by the tables. All others registering, after Fundraiser table, they can choose to go to sponsorship, and managers tables. Then they much check out. Will have to set up chapel to help keep people moving. We will have 3 cashiers and 3 printers, and then we will have 6 lap tops for check out. Signs will be up and around everyone to help. Sending PJ request for banners to be made. Also make sure that Maryville Village Employees get 50% off their registration fee only. Board members are 100% free. John will pick up breakfast. Rita will have snacks for lunch and John will make plans and reservations for dinner both weekends. All board members and families are invited. John will pick up signs in Highland Wed 1/8/14 for registration. Rita will pick up last supplies needed for registration. Paul will shut off pre-registration on Friday Afternoon will note on website it will be back up on Sunday. Then we will turn on for 1 week and then turn off the next Friday before final registration. Then the following Sunday Late Registration will be added to website. Need more volunteers for both registration dates. Several teenagers will be asked to help out and work at registrations. Meet at 8:00 both Saturday on the West end of building. Dana, Chris and Leslie will not be at 18<sup>th</sup> registration. Tracy 12:00 both days. Paul will be gone around 1 - 3 on the 18<sup>th</sup>.
