- School Year vs Birth year (update by-laws to align with Birth Year) - Vote passes (yea - 9, nay - 0) **By-laws must be updated**
 - Feedback from another league: 3 Goal Differential (update our by-law to state "less than 4 goals"). Proposed addendum to **by-law 12.a.** - pull 1 player at 3 goals, second player at 4 - regain 1 player if differential goes back to 3, regain 2nd player if differential goes below 3. Coaches should restructure their field positions to decrease the advantage. By-law passes (yea 7, nay - 2) **By-laws must be updated**
 - Sussex County Soccer League is looking to host a League crossover tourney in the Spring(U10-U15). Rich will get more information to share with the League.
