Yearly Financial Report

We have taken some hits over the last couple of years. We went from a 12-man bracket for State to an 8-man bracket, which reduced our income from State by \$8400 while our expenses remain the same of higher. We also had unexpected expenses in umpire fees. We've worked hard to spend responsibly while continuing to meet our expectation of creating a great experience for our baseball players.

It was motioned and 2nd to approve the budget for the current season.

After discussion, motion was approved 9-0

In September, we will discuss new sponsorship ideas and the possibility of going

back to a 12-man bracket for Nat and Amer State.

Umpire fees The rate of increases has been as follows: 2017 7.69%, 2018 5.39%, 2019 9.59%. The

proposed increase is another 9.59%.

It was motioned and 2nd to approve an umpire rate increase for State

Tournament. The increase is valid for the 2022-2024 seasons.

After discussion, motion was approved 8-0-1.

Approved rates for 2-man State game MN-MA-MF \$110 10% increase JN-JA-JF \$123 9.82% increase SN-SA-SF \$134 8.94% increase

Overall it is a 9.59% increase

Umpire Issues

Jay spoke with Dave at NYBUA. If districts have concerns regarding umpires it is suggested that they meet with the appropriate umpire association to discuss. NYBUA did pick up 50 2022 JBO rulebooks from Lynn, so they have JBO rulebooks for their training and clinics. Of course the rulebook is also posted online. It may be prudent to look within your own district or association for umpires.

Team Fees-2023

Umpire rates continue to increase as does the cost for rulebooks and all state tournament items. History of team fees: \$40 in 2013, \$45 2014-2019, \$55 2020-2022. It was motioned and 2nd to increase team fees to \$70 beginning with the 2023 season.

After discussion, motion was approved 9-0
