## What is a Regular Member?

Per Article III, Section 1 of the Maitland Little League Constitution, a Regular Member is any adult person who is sincerely interested in active participation to further the objective of the Local League. Per Article III, Section 2(b), Regular Membership is granted upon election by a unanimous vote of the Board of Directors.

Regular Members in good standing automatically include all current Managers, Coaches, Volunteer Umpires, and Board Members. All other adults who wish to become Regular Members must complete this application and be elected by unanimous Board vote.

Only Regular Members in good standing may vote at General Membership Meetings, serve on the Board of Directors, hold officer positions, or serve on any league committee per Article V, Section 4 and Article VI, Section 4(d).

## Background Check Requirement

Per the Maitland Little League Constitution and Little League International Regulation I(b) and I(c) 8 and 9, a background check conducted by the league must be completed before any Regular Member may be considered for a seat on the Board of Directors. A background check will be initiated upon submission of this application. Submission of this application does not guarantee membership. Membership requires a unanimous vote of the Board of Directors.

## MEMBER RIGHTS & RESPONSIBILITIES

What Regular Membership means at Maitland Little League

### Rights of Regular Members

- Vote at General Membership Meetings per Article V, Section 4
- Be eligible for election to the Board of Directors
- Serve on league committees
- Receive notice of all league meetings per Article VII, Section 4(c)
- Request a copy of the league constitution

### Responsibilities of Regular Members

- Uphold the Maitland Little League Constitution
- Abide by all Little League International Rules and Regulations
- Actively participate in furthering league objectives per Article III, Section 1
- Maintain good standing to retain voting rights
- Not be actively engaged in any other baseball or softball program per Article III, Section 3(b)
- Conduct yourself in a manner not detrimental to the league per Article III, Section 4(a)

### Important Notes:

Membership may be suspended or terminated by a two-thirds vote of the Board for conduct detrimental to the best interests of the league per Article III, Section 4(a). Members must be given notice of charges and the opportunity to appear and respond before any disciplinary action is taken. Per Article III, Section 3(b), Regular Members should not be actively engaged in the promotion or operation of any other baseball or softball program.
