### Background Check Process

DYBSI Background Check Process Board members, head coach, and assistant coach will be required to complete a background check each calendar year. Background checks are used to reduce any risks and to protect the safety of the youth we serve. DYBSI has formed a partnership with Protect Youth Sports to obtain a pass/fail background check alerts. Coaches have no financial obligation to complete the background check. After the registration is complete, DYBSI will transmit the information to Protect Youth Sports. Coaches who do not submit a background check or fails a background check is prohibit from serving in an official DYBSI position in any capacity. The DYBSI Board will review failed background check to determine volunteer eligibility.
